Sir/Madam,

This is to inform you that, as per the orders passed by Madam Vice-Chancellor (vide its no. Affi.Gen.1/V.C.Order/2013-14/367 dated June 1, 2013) and as per the No Objection Certificate issued by the office of the Joint Director of the Region concerned and as per the Government order referred above, the First Time Temporary Affiliation has been granted to your Sanstha to start Shriram Mahila Vidnyan Mahavidyalay, Paniv, Tal. Malshiras, Dist. Solapur to start First Year Bachelor of Science (Three years Degree) Course (English Medium) for the academic year 2013-14 with intake capacity of 120 students, in accordance with the provisions of Section 87 of the Maharashtra Universities Act, 1994, subject to the following terms and conditions:

- 1. The college concerned should not admit students beyond intake,
- The college on completion of 5 years have to apply for NAAC accreditation within one year failing which their affiliation will be automatically cancelled
- It may be noted that if the Trust is not able to enroll at least 50% of the intake capacity their permission for continuation for the said course is liable to be discontinued by the Joint Director of the Region Concerned.
- The First Time Temporary Affiliation has been given for the academic year 2013-14 and as per provision in Section 82(5) and 83 (5) of the Maharashtra Universities Act, 1994.

- The academic, building sufficient to accommodate the faculties, lecture/seminar rooms, library and laboratories with a minimum of 15 sq.ft. per student in lecture/seminar rooms/library and 20 sq.ft. per student in each of the laboratories,
- The Trust shall appoint the number of teaching and non-teaching staff required as per University norms,
- The adequate civic facilities for essentials like water, electricity, ventilation, toilets, sewerage etc in conformity with the norms laid down by the Central/State PWD,
- 5. The library with at least 500 books, or 100 books in different titles on each subject, whichever is more, of the proposed programmes to include both text books and reference books, besides two journals per subject, along with a book bank facility for students belonging to other Schedule Castes, Scheduled Tribes and such other sections as may be specified by the UGC from time to time,

In particular, it shall produce evidence of creating and maintaining a Corpus Fund permanently in the name of the college by way of irrevocable Government Securities of Rs.15 lakh per programme as your college will be conducting programme in Science or FDRs for like amounts jointly held by the college and the University for a minimum lock in period of three years. The interest accrued out of it may be utilized by the college with the prior permission of the University for strengthening its infrastructure facilities,
